Huntingdon Behavioral Health, formerly Huntingdon Health Services, was founded to provide psychiatric and psychological care to those in need of diagnosis and treatment of a mental health condition. Huntingdon Behavioral Health's program has been carefully developed to assist adults with mental health issues to achieve their highest level of independence and functioning.



We have served Florida for over 20 years and we know our state regulations. We are a full-service behavioral health provider with a team of over 100 clinicians, serving more than 220 skilled nursing facilities.

Our model of care provides a psychologist and a psychiatrist assigned to each facility. Upon receipt of an attending physician's order, the psychologists perform an initial evaluation and provide psychotherapy and/or behavioral management when clinically appropriate. Licensed clinical social workers are added to assist with larger long-term care caseloads if needed. Our psychiatrists also perform an initial evaluation and psychotropic medication management when clinically indicated. This collaboration provides continuity of care for our patients.

Our psychiatrists and psychiatric nurse practitioners serve as consultants to the facility's attending physicians and nursing staff, lending their medical expertise to improve the quality of care for their patients.

We've developed our program to assist adults in their behavioral and mental health. It is our hope that every patient achieves his or her highest level of independence and functioning.

We have the largest team of Clinical Psychologists in Florida serving our partnered facilities, to provide support with behavioral issues from a non-pharmacological perspective. Whenever possible, our clinical teams employ a multidisciplinary approach to achieve optimal results using non-pharmacological treatments as they integrate pharmacological and behavioral interventions.

Gradual Dose Reduction (GDR) is a top priority for our medication management teams. While focusing on the individual needs of each patient, they monitor the use of psychotropic drugs and help to ensure that state and federal guidelines are met. We have our own psychopharmacological analysis process, guided by next generation software, that can track data at our contracted facilities, spotting trends in the data and communicating it to the interdisciplinary teams ahead of CMS monthly data publication.

Our Pharmacy Consultant serves all our contracted facilities and guides data collection, GDR goals, and consults with prescribers, primary care physicians, and the interdisciplinary team, in achieving data driven results to improve facility star ratings and ensure great behavioral management outcomes. 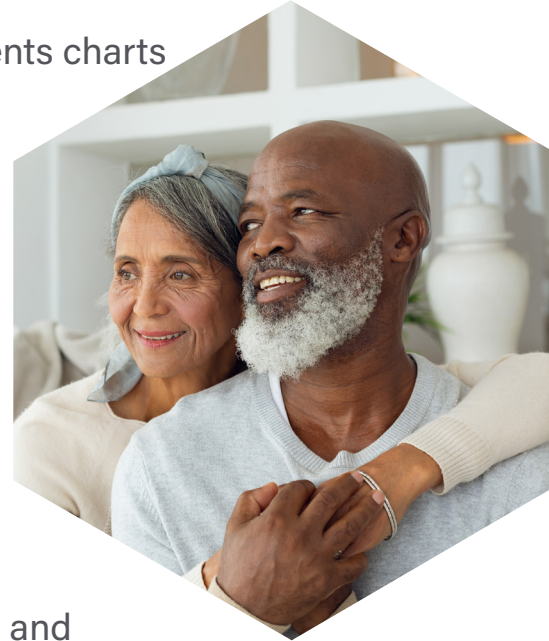
